Resolution No. 18, Series of 2013 SUBJECT: Approval of SRWD Budget for the Year 2014

WHEREAS, the General Manager submitted the final draft of the proposed budget for the year 2014 in the total amount of Fifty-Two Million Three Hundred One Thousand Three Hundred Eighty One Pesos & 42/100 (P52,301,381.42);

WHEREAS, in the proposed budget for the year 2014, the amount of Thirteen Million One Hundred Eighty-Four Thousand Six Hundred Pesos (P13,184,600.00) will be sourced from the remaining proceeds of the approved DBP loan while the balance of Thirty-Nine Million One Hundred Sixteen Thousand Seven Hundred Eighty One Pesos and 42/100 (P39,116,781.42) will be sourced from internally-generated funds of the District;
