The Santa Rosa (NE) Water District (SRWD), through the Corporate Budget Approved by the Board of Directors intends to apply the sum of One Million FiveThousandpesos (Php 1,005,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract Supply and Delivery of1,500 pieces ¾ inch Brass Safety Valve with Lock Key. Bids received in excess of the ABC shall be automatically rejected at bid opening.

For ¾ inch Brass Safety Valve with Lock Key: Brass Body, Wrench Type Magnetic Infused Key, PN 16 Weight = not less than 268.50 grams Height = 44.50 mm; Length = 61.0mm

- 2. The SRWD now invites bids for the Supply and Delivery of1, 500 pieces ¾ inch Brass Safety Valve with Lock Key. Delivery of the Goods is required 7 days after the receipt of NOTICE TO PROCEED. Bidders should have completed, within 10 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eliqible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail"

criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from SRWDOfficeand inspect the Bidding Documents at the address given below during weekdays from 8 am to 5 pm.

A complete set of Bidding Documents may be purchased by interested Bidders from January 18 to 12:00 noon of February 8, 2021from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount ofFive Thousand Pesos (P5,000.00)

Bidders are required to attend the Pre-Bid Conference and conduct product presentation and submit sample/ samples of product. Failure to conduct presentation is a ground for disqualification.
- 6. Bids must be delivered to the address below on or before 12:00 noon of February 8, 2021. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on February 8, 2021 at 2 o'clock in the afternoon at SRWD Office Santa Rosa – Fort Magsaysay Road Brgy. Rizal, Santa Rosa Nueva Ecija. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
