INVITATION TO BID FOR DRILLING OF EXPLORATORY/PRODUCTION WELL

1. The SANTA ROSA (NE) WATER DISTRICT (SRWD), through the Corporate Budget Approved by the Board of Directors, intends to apply the sum of Two Million Four Hundred Eighty Thousand and 00/100 Pesos (Php 2,480,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Drilling One (1) 80m Exploratory/ Production Well at Sitio Tumana, Barangay La Fuente, Santa Rosa, Nueva Ecija. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Location of Project : SRWD Lot, Sitio Tumana, Barangay La Fuente, Santa Rosa, Nueva Ecija

Brief Description : Well to be drilled is by Rotary Drilling Method according to the following parameters:

Target Depth = 80m
 Borehole Size = 350mm (14")
 Blank Casing = 200mm (8")
 Screen Size = 200mm (8")
 Cement Grout = 15m
 Gravel Pack = 4 – 5mm

Approved Budget for the Contract : Php 2,480,000.00 (VAT Inclusive)

Contract Duration : 90 Calendar Days

2. The Santa Rosa (NE) Water District now invites bids for the project Drilling One (1) 80m Exploratory/ Production Well at Sitio Tumana, Barangay La Fuente, Santa Rosa, Nueva Ecija.
 3. Bidders should have completed, within THREE (3) YEARS immediately prior the date of bid opening herein, a SINGLE LARGEST COMPLETED CONTRACT (SLCC) involving well drilling for local water district of at least FIFTY PERCENT (50%) of the ABC and should possess a valid PCAB License applicable to the contract. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from SRWD and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
 5. A complete set of Bidding Documents may be acquired by interested bidders on September 8, 2022 to 12 noon of September 28, 2022 upon payment of a non- refundable fee of Php5,000.00.
 6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
 7. The SRWD will hold:

 - Bid Submission on or before September 28, 2022 at 12:00 noon
 - Bid Opening September 28, 2022 at 2:00pm
 - Venue Santa Rosa (NE) Water District Office

 - Barangay Rizal, Santa Rosa, Nueva Ecija.

8. Bids must be duly received by the BAC Secretariat at the address below on or before September 28, 2022 at 12:00 noon. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. SRWD assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of bids.

10. SRWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
