- The Citizen's Charter was first published on September 16, 2009 and underwent review and revision on September 2011 and 2013 as required under Section 4, Rule IV of the IRR.

The Citizen's Charter already shows the improvements in the processing of the District's transactions that resulted from the process review of frontline service delivery, specifically: streamlining of procedures in accepting application for service connection, shortened turnaround time in receiving payments from concessionaires, streamlining of procedures in accepting service request of concessionaires.
